



GOVERNMENT OF CROSS RIVER STATE OF NIGERIA

Law No.2020

A Law to appropriate out of the Consolidated Revenue Fund for the services of the Government of Cross River State of Nigeria for the year ending on the 31st day of December, 2020, the sum of Fifty-Six Billion, Eight Hundred and Seventy-Six million, Two Hundred and Fifteen thousand, Eight Hundred and Twenty Nine Naira and Ninety Six kobo (₦56,876,215,829.96) for the period aforesaid, to authorize out of the Capital Development Fund, the expenditure of Ninety-One Billion, Three Hundred and Eighty Million, Six Hundred and Fifty-Nine Thousand, Four Hundred and Twelve Naira (₦91,380,659,412.00) only .

Commencement (1st January, 2020)

THE CROSS RIVER STATE HOUSE OF ASSEMBLY enacts as follows:-

Enactment

1. The Accountant-General of Cross River State of Nigeria may, when authorized so to do by warrants issued by the Governor pay out of the consolidated Revenue Fund of the State during the year ending on the 31st December, 2020 the sums specified by the Warrants, not exceeding in the aggregate of Fifty-Six Billion, Eight Hundred and Seventy-Six million, Two Hundred and Fifteen thousand, Eight Hundred and Twenty Nine Naira and Ninety Six kobo (₦56,876,215,829.96) only being the total of the amount set out opposite the Heads of Expenditure in schedule 1 and may for the like period and in like manner pay out of the capital Development Fund the sums specified by warrants not exceeding in the aggregate of Ninety-one Billion, Three Hundred and Eighty Million, Six Hundred and Fifty Nine Thousand, Four Hundred and Twelve Naira (₦91,380,659,412.00) only, being the total of the amounts set out opposite the Heads of Expenditure in schedule 2.
2. The said sum, not exceeding in the aggregate of One Hundred and Forty-Eight Billion, Five Hundred and Four Million, Eight Hundred and Fifty-Four Thousand, Nine Hundred and Sixty Eight Naira and Ninety-Six Kobo only, shall be appropriated for the purpose and in the manner expressed in the relevant schedule.

Issue of ₦56,876,215,829.96 and ₦91,380,659,412.00 out of the consolidated Revenue Fund and Capital Development Fund respectively in schedules 1 & 2

Appropriation of ₦148,504,854,968.96
